## PDDBM BHM FASHION SHOW VENDOR APPLICATION FORM

In honor of Black History Month, we are presenting our annual PDDBM (Please Don't Die Black Men) Fashion Show that will feature uplifting and inspiring designs for African Americans. The purpose of the fashion show is to bring awareness and educational exposure to African Americans who have contributed significantly to the development of the fashion industry in the United States since the 1860s. This event will take place at The Clark County Fairgrounds, 17402 NE Delfel Rd, Ridgefield, WA 98642, on Saturday, February 8, 2025, from 10 p.m. to 5 p.m.

#### PLEASE INITIAL YOUR UNDERSTANDING OF THE FOLLOWING:

- We would like an exhibit at the PDDBM BHM Fashion Show. Attached is our payment of \$100, the cost of a space at the fashion show.
- Being a vendor and being a sponsor are two different things. I can choose to be both, but they both come with different perks/advantages.
- The deadline for securing a vendor space is January 6, 2025. Vendor space is first come, first served. The Accept/Reject Notification deadline date is December 16, 2024. Any applications and fees processed after that are based on space availability.
- We are NOT Food Vendors. We are NOT selling food that we supply.
- Vendor setup starts at 9 am and must be completed by 9:45 am.
- Vendor breakdown starts at 5:15 pm and must be completed by 6:00 pm.
- We will be given 1 table and 2 chairs for the vendor fee. Additional tables cost \$100/table.
- We cannot bring our own tables.
- Parking costs \$6/vehicle which is paid directly to the Clark County Fairgrounds upon arrival.
- We will not need electrical outlets. If we do, we have attached an additional \$150 per outlet.
- NO vending/selling is allowed between 11:45 am 2 pm during the actual fashion show.
- Kindly be informed that the event doors will be secured at 11:45 am. While you are free to exit at your convenience, re-entry will not be permitted until 2 pm. We kindly request your cooperation in refraining from entering or exiting during the

- Black History Month celebration, as this ensures a respectful and uninterrupted experience for those on stage.
